g) Seek ideas of how the church can serve the community

Astrid Domingo Molyneux: Serving in Almondsbury Community Shop - this is a good way to meet other people and give ministry to the community.

Astrid Domingo Molyneux: AVE Committee - Almondsbury Village Events organise village activities and further members would be welcomed, which also helps to build the link with the Church.

Graham Jeffery - Café Almondsbury - It was asked if the café could be restarted, but due to lack of volunteers it is not currently possible. Outreach work is obtained through Toddlers and Messy Church when residents from The Glebe visit for extra social interaction.

Astrid Domingo Molyneux - Footpath (Gravel path from Hollow Road to the Churchyard) - the question was raised as to who was responsible for the footpath as it requires resurfacing to make it more accessible to wheelchair users and safer for pedestrians. Clare Jefferis advised it is believed that South Gloucestershire Council have the responsibility for maintaining the footpath and to try and lobby Almondsbury Parish Council to consider resurfacing.
